## Organization Award of Merit Criteria

Purpose is to recognize:

- ❖ an organization that has shown outstanding leadership and commitment to professional development of their own security professionals through certification.
- ❖ organizations that make significant contributions toward the advancement of ASIS certification programs.

Examples of potential award-winning actions:

- Implementing the CPP, PSP or PCI designation as a prerequisite (or standard) for security professionals in their firms
- Commitment to certifying existing security staff across an organization
- Recognizing the value of security certification across their organization by developing, promoting and supporting the CPP, PSP and PCI designations internally
- Supporting employee ASIS certification, and participation in ASIS International as volunteer leadership positions on the local, regional, national or international levels, and/or as a supporting organization.

The award will be given on an "as appropriate" basis, with no requirement that it be made annually. **Nominations will be accepted from any member in good standing of the Society and must be submitted to the Professional Certification Board by June 16.**

Organizations employing a current sitting SRVP, RVP or member of the ASIS Board of Directors are not eligible, unless the PCB makes the nomination directly. In no case are organizations employing current members of the PCB eligible. Institutions or individuals who have monetary or an otherwise vested interest in ASIS International certification programs cannot be nominated for an award.
