### Certification Exam Updates

#### CPP Job Analysis

The Certified Protection Professional (CPP) exam will soon be updated based on a job analysis that will be conducted this year. Approximately every five years ASIS reviews the security management profession to ensure its CPP designation accurately reflects job-related activities, competency, and professional standards. It is a systematic process to identify the essential elements of a job, including major domains of responsibility. *Updates will be reflected in CPP exams administered in the latter half of 2015.* The PCB will be reaching out to volunteer leaders in efforts to encourage participation of subject-matter experts in certification activities. Please be on the lookout for a pilot and industry-wide random survey. Encourage your constituents to become involved! See other tentative activities scheduled below:

#### Nomination Deadlines – June 16, 2014

The PCB Certification Awards was launched in mid-April. The board is calling on all volunteers to participate in nominating organizations and/or certified individuals who merit recognition. Please do not let their efforts go unnoticed. There are two award categories:

- Regional Award for volunteers who have made a difference at the chapter/state level;

### Certification Misuse

#### Unauthorized Usage of Certification Marks

From time-to-time, there are proactive volunteers who alert the PCB of infringements, but very often there are many cases that go unreported. For those who are concerned about the right to use the certification designations, these marks are registered with the United States Patent and Trademark Office. They are also trademarked by the Society internationally and ASIS trademark attorneys assist in enforcement efforts. The marks are registered (or are the subject of pending applications) in more than forty-five countries worldwide. The domestic and international registration of ASIS marks provides the Society with enforcement rights in the courts of these countries, should it become necessary.
