PCB Welcomes A New Member

Keith L. Kambic, CPP

The PCB is pleased to welcome Keith L. Kambic, CPP. Kambic has more than 23 years of experience in the security field, encompassing areas such as logistics, retail, corporate, consulting, and real estate. Currently, he is the director of security and life safety - U.S. Equities Asset Management division - for the Willis Tower (formerly Sears Tower) in Chicago. The Willis Tower is listed as a critical infrastructure and national icon. It holds over 110 tenant companies and has a daily population of 25,000. Day-to-day responsibilities include the management of security guard operations, physical security, life safety, and business continuity. The building is also a top tourist attraction with an

annual throughput of 1.4 million, which requires heavy security support. Security operations are vast and include screening, parking facilities, dock operations, visitor management, front desk and doormen staff, and off-duty police support for a total employee count of over 100. Kambic's department also oversees code compliance, insurance regulations and claims management, evacuation procedures, and emergency response for the facility. In addition, the department liaisons with all public agencies (Chicago Police and Fire Departments, Secret Service, FBI Joint Terrorism Task Force and the Department of Homeland Security).

"Kambic is a seasoned security professional who brings the right mix of expertise in security and corporate management to the certification program. The PCB has a packed agenda for 2010 and he will play a pivotal role as we continue to meet the needs of security leaders wishing to grow, transition, or maintain visibility within their field through innovative learning."

Kambic became a CPP in 2001 and has been an active member of ASIS International for many years. His service to the Society includes former positions as vice chairman and chairman of the Commercial Real Estate Council, and member of the original Critical Infrastructure Working Group (that produced the ASIS working guide). PSP Job Analysis Survey

March 16, 2010 Launch

To ensure the Physical Security Professional (PSP) role delineation model reflects current job-related activities, the Association has collaborated with Professional Examination Services (PES) to develop and distribute a random-validity survey for data collection on required tasks, knowledge, time, and various risk assessments.

It is important that you review and return the PSP questionnaire to PES by April 5, 2010 or sooner.

This survey is instrumental in ensuring that the PSP designation continues to represent the levels of knowledge and types of tasks required of today's security managers and directors.

Approximately 1,000 survey participants have been selected to complete an online questionnaire which will cover the PSP domains of practice. A PSP-taskforce committee will be established to review the knowledge and task for these respective domains. The PCB is calling on all PSPs, who were randomly selected, to complete and return the survey by Monday, April 5, 2010. Participation is crucial! Those who complete the questionnaire will receive five (5) continuing professional education (CPEs) credits as a special thank you for their dedicated time. Reminder - Updated CPP and PCI Exam Forms Beginning June 1, 2010!

This is an important reminder about the implementation of new test forms for Certified Protection Professional (CPP) and Professional Certified Investigator (PCI) exam for candidates preparing to test on or after June 1, 2010.

The new exam blueprints (or domains of study) for each exam may be viewed online: <u>CPP</u> and <u>PCI</u>.

*Please note that updated CPP and PCI exam questions were developed using the current CPP and PCI reference books. It is recommended that candidates focus their preparation for the examination using these resources.

The nomination process is simple:

- 1) Review the award criteria and note exclusions.
- 2) Fill in the nomination form (ensure you provide sufficient supporting documentation and signatures).
- 3) Submit to appropriate listed contact by given deadline.

The CPP reference set without the POA Manual in the ASIS Bookstore is to accommodate those candidates who already own or have access to a current POA Manual.

If you are a POA subscriber and are not receiving any POA email, at least quarterly, please *notify us* promptly. Council and Chapter Certification Representatives

Tips on Roles and Responsibilities Courtesy of Keith Blowe, CPP

(PCB Committee Chair for RVPs/Councils/Chapters)

You have been chosen by your chapter to be their certification representative, but now you are thinking about the most effective ways for you to serve and offer support. Here are a few examples where you can play an active role:

Recruiting Potential Certificants

Every year, there are various certification initiatives (new and ongoing) that require input from ASIS certificants. As a representative, you can help by recruiting ASIS certified professionals for activities such as Item Development Group meetings and encouraging their input through job analysis surveys. Always feel free to contact the certification department to inquire about upcoming events that you believe may be of interest to your council and/or chapter members.

Mentoring those Seeking Certification

At some point in time, those seeking an ASIS designation may hit the "I need to take the certification leap" stumbling block. Sometimes, it's the extra guidance that they receive from those already certified that can help them take the next step. You can help by being a mentor for potential CPPs, PCIs, and PSPs, following up on requests for exam information or even offering guidance on how to accurately complete an application form (hence, helping avoid processing delays).

Writing an Informative Column

The PCB often encourages readers of the certification newsletter to share content that they believe to be valuable with other security professionals. Whether through the newsletter or ASIS Web site, information is always at your

fingertips. You can write a certification column in your chapter's newsletter and link with information from the ASIS certification newsletter, Web home page, etc. The PCB also encourages you to be on the lookout for the next time your colleague writes an interesting security article such as companies using ASIS certified professionals as a hiring standard or organizational support of employees in earning their designations. This would be a great informational piece to share with other readers!

Gathering Information

Surveys are one of the best ways to gather information and provide feedback. If your council or chapter conducts a survey, you can collect, analyze, and forward suggestions to the PCB, and we will be happy to share your insights and findings to assist a much broader audience of current certificants. Another idea is assembling of the names of organizations, associations, and companies in your geographic area that could be good targets for information about the value of the CPP, PCI, and PSP designations.
