The ASIS UK Chapter was well represented at the awards with Chapter Chair David Clark, CPP, PSP, PCI, presenting an award on behalf of The Security Commonwealth which he also chairs, and Chapter Vice Chair - strategy, Mike Hurst, presenting an award on behalf of the chapter alongside Stuart Lowden (a former chapter chair) of Wilson James. Also present were Chapter Vice Chair - operations and Assistant Regional Vice President (ARVP) Graham Bassett; Chapter Treasurer Bruce Braes, CPP; and committee members Russell Penny, CPP; Stuart Eustace, CPP; and Steve Kenny. Judges included ASIS Regional Vice President Andy Williams, CPP; Dave Clark; James Willison; Barrie Millett (former chapter chair); Emma Shaw (former assistant regional vice president); and Martin Smith MBE.

Many ASIS UK chapter members did well in the awards, with John Reading of Jaguar Land-Rover winning Outstanding In-House Security Manager/Director, while Peter Houllis, 2020 Vision Systems collected the award for Outstanding Security Installer. 

For the first time in Switzerland, the chapter was proud to present its annual award to a young professional in recognition of her academic achievement in the field of security. A jury composed of Aurore Chatard, Jean-Pierre Therre, and Stéphane Vuille, PCI, selected the work of Camilla Romero-Giudici, a student with the Ecole des Sciences Criminelles in Lausanne, Switzerland, for her innovative research. Romero-Giudici studied Internet discussion forums to determine if they could be used as information sources to detect and locate vendors of counterfeit luxury watches. The depth of her work demonstrated the applicability of her methodology to other industries that are victims of counterfeit manufacturing and distribution.

On 16 February, the ASIS International Austria Chapter had its first meeting of 2017 at the premises of Andritz Group upon the invitation of chapter member David Zrost, the Andritz Group CSO.

Chapter Chair Werner Preining, CPP, welcomed 20 members and 7 guests during his opening statement.

This was followed by a brief presentation of the Andritz Group by David Zrost. The group has five divisions with about 25,000 employees and operates world-wide at about 1,400 locations. The five divisions are hydro, pulp and paper, metal, separation (waste management), and power generation. An overview was provided about how security was handled and what tools were used to safeguard the security of employees and assets. The next speaker was Andreas Papp from SOS Children's Villages. His position in this nonprofit organisation is to coordinate global emergency response. Worldwide the SOS Children's Villages run about 550 projects, 20 hospitals, and 120 kindergartens, schools, and children's villages.

Mr. Papp reported on a sharp increase of violence against humanitarian aid workers and the instances of kidnapping in several countries. To be safe, humanitarian aid workers must be accepted by all opposing groups within the region. Once a written warning from one of the groups is received that the presence of humanitarian aid workers is no longer wanted, it is time to leave the region without a second thought. Programmes used for safe evacuation and travel routes were showed.

Some of the operations of SOS Children's Villages are in dangerous countries like the southern Sudan, Syria, and Yemen, to mention only a few. While most of the time NGOs share security information, there is a certain competition between them when it comes to funding. Bribery was addressed during the discussion as an issue that needs to be handled according to local customs - customs that cannot be judged by a Western mentality. After the presentation, it was agreed to create a working group to exchange security views and procedures between profit and nonprofit organisations.

The involvement of the tobacco industry in an EU-wide track and trace system to tackle smuggling has divided relevant stakeholders. In July 2016, the European Commission decided to end an anti-smuggling deal with tobacco firm Phillip Morris International (PMI) and pledged to focus on the new EU tobacco directive (TDP), as well as the Framework Convention on Tobacco Control (FCTC) with the World Health Organisation (WHO) to fight against illicit tobacco trade
