You'll meet for a three-day, face-to-face at ASIS Headquarters to be trained on how to write and review items. You will then be required to write 10 items per year for the two-year assignment. All items will be written and stored using Prometric's item banking system. You must hold a current CPP to participate.
- PCI Item Writing Panel** – We are seeking 10-12 item writers to create new exam items. This project requires a two-year commitment. You'll meet for a three-day, face-to-face at ASIS Headquarters to be trained on how to write and review items. You will then be required to write 10 items per year for the two-year assignment. All items will be written and stored using Prometric's item banking system. You must hold a current PCI to participate.
