Applicants must answer all ten questions in two (2) typed pages or less to be eligible for consideration.

You may elect to submit a one (1) page attachment with additional comments for the review committee to consider. Do not submit supplemental materials such as departmental citations, letters of commendation, newspaper clippings, video-tapes, or DVDs/CDs. **Applications that do not follow these guidelines will be ineligible for consideration.**

Applications will be evaluated based on the significance of the P3 contribution with regard to the criteria cited in each question. The grant will be awarded to a full-service law enforcement agency to support a currently active P3 program.

1. Statement of Problem - Explain the specific safety and/or security problem, local issues, or concerns that created the need for a P3 program.
2. Statement of Solution - Describe how the joint project or program successfully resolved the issues identified above.
3. How has this cooperative effort/solution enhanced public safety and/or private security?
4. Describe how there is proportional investment, input, and leadership among all agencies and organizations participating in the program.
5. Explain how the project or program presents an innovative approach to enhancing public safety and private security.
6. Explain how the program demonstrates its potential for permanence or longevity in the public safety/private security community.
7. How is the program's outcome continually measured to insure it performs as intended?
(i.e.: assurance standards and/or performance metrics)
8. Describe the channels of communication and the frequency of those communications.
9. How do the participants demonstrate executive leadership to oversee/manage the program?
10. Explain how this program could be replicated and implemented in other communities and what obstacles a startup organization might encounter.
