# Security Management Reprint Permission Policy and Copyright Guidelines

# <u>Articles</u>

All contents of *Security Management* are copyrighted. A few articles in *SM* are copyrighted by their authors. In those cases, permission to use the material must be obtained from the individual authors. All other material is copyrighted by ASIS International. All material requires permission before being photocopied/reprinted. All requests to use material from *Security Management* must be made in writing. Please use the attached form.

# <u>Artwork</u>

Illustrations and photographs appearing in *Security Management* are purchased by the magazine for one time use only. Permission to reproduce artwork must be granted by the artist who will set payment conditions. If the requestor supplied art or photos, or if *Security Management* incurred no expense in obtaining them, permission will generally be granted at no charge.

# **Miscellaneous**

Reproduction of the *Security Management* cover is not permitted. Both the Security Management and ASIS International logos are trademarked and may not be reproduced.

# When permission to use an article is granted, a credit line shall appear in a box on the front page on all reproductions that reads:

© (**year)** ASIS International, 1625 Prince Street, Alexandria, VA 22314. Reprinted by permission from the (**month/year)** issue of *Security Management* magazine.

# Types of Uses and Associated Costs

<u>Individuals</u> wishing to distribute single copies of an article for internal use (within their own company) will be permitted to do so free of charge upon receipt of permission request form.

<u>Nonprofit uses</u> (such as in free or minimally charged conferences) will be permitted free of charge upon receipt of permission request form. ALL ASIS CHAPTER USAGE FALLS INTO THIS CATEGORY.

<u>Educational institutions</u> may use articles as study material. In courses for which students are charged tuition, there will be a charge of \$50 per article, per course, per semester.

<u>Conferences, seminars, and workshops</u> for which registration fees in excess of \$50 are charged will be charged a fee of \$50 per article, per use.

<u>Promotional/informational uses</u>: A firm wishing to reprint articles for handouts to clients and prospective clients will be charged a fee of \$50 per article except when the company has materially assisted in the preparation of that article.

<u>Use of Security Management Graphics</u>: Companies will be charged a fee of \$150 for reproduction of original graphics.

<u>Publishers (books and magazines)</u>: Quotations of no more than two paragraphs will be permitted at no cost. For longer passages or entire articles a fee of \$75 per thousand words published will be charged. In-house newsletters are permitted to use material at no charge.

# Instructions for requesting photocopying/reprint permission

1. Complete the reprint permission form.

2. Mail the form to *Security Management*, 1625 Prince Street, Alexandria, VA 22314, Attn: Flora Szatkowski; e-mail to SMeditorial@asisonline.org; or fax it to 703/518-1518.

3. Upon receipt of the request, *Security Management* will determine who holds copyright. If ASIS holds copyright the requestor will be notified of any charges; upon receipt of payment ASIS will send the requestor a letter granting permission to photocopy/reprint the article. If copyright is not held by ASIS an effort will be made to reach the author to gain permission on the behalf of the requestor. In some cases the author may wish to speak directly to the requestor.

4. If you know that you will be requesting permission for several articles a year, please make photocopies of this form for your files. Each time that you make a request please fill out the form in full.
